## MAURITIUS - AFRICA SCHOLARSHIP SCHEME 2022 CALL FOR APPLICATIONS Award of Scholarships by the Government of the Republic of Mauritius

The Government of Mauritius is awarding scholarships to deserving students who are resident citizens of member states of the African Union or African Commonwealth countries, as per the following criteria:

- 1. For undergraduate programmes, applicants should be above 18 years of age and should not have reached their 26th birthday by 22 August 2022.
- 2. For Master's programmes, applicants should not have reached 35 years and, for PhD programmes, applicants should not have reached 40 years by 22 August 2022.
- 3. Applicants must have already applied for a full-time on-campus programme (Diploma, Degree, Master's or PhD) at a public Higher Education Institution in Mauritius (listed in Section 8 in the appropriate Guidelines for Applicants) for academic year starting in 2022.

4. The scholarship will be for a maximum duration as indicated in the table below or the minimum course duration whichever is lesser.

SN	Programme of Studies	Maximum Duration
1	Undergraduate Diploma	Three (3) years
2	Undergraduate Degree	Four (4) years
3	Master	Two (2) years
4	MPhil / PhD	Four (4) years + 6 months for the transfer from MPhil to PhD
5	PhD	Three (3) years

The Scholarship will support successful candidates in meeting their tuition fees and in contributing to their living expenses during their studies in Mauritius. Furthermore, the scholarship covers a return airfare by the most economical route. This will be valid for travel from the country of origin at the beginning of the studies and back to the country of origin upon successful completion of studies.

Since in Mauritius only vaccinated students are granted access to higher education institutions, successful candidates will have to be vaccinated prior to coming to Mauritius. For successful candidates who cannot for medical purposes be vaccinated, they will be required to produce duly certified medical certificates.

To enter Mauritius, students must present a negative PCR test taken within 72 hours before departure from their home country. Covid-19 testing will be required upon arrival.

11. Application Form (Applicants are invited to fill in the form electronically before printing)

Application for the scholarship can unity be made on the application form, duly filled-in. Section 5 of the application form should be endorsed and completed by the Nominating Agency in the country of citizenship of the applicant. An application under this Scheme is to be made solely through the Nominating Agency responsible for the processing of scholarships in the country of citizenship of the applicant. Such Nominating Agency, which may typically be part of the Ministry of Education in the country of the applicant, will then shortlist and endorse the applications of a maximum of FIFTEEN (15) eligible candidates (five in each category of Undergraduate, Masters and MPhil/PhD) and submit the duly completed application forms as per the table below:

## MAURITIUS – AFRICA SCHOLARSHIP SCHEME 2022 GUIDELINES FOR NOMINATING AGENCIES

#### Introduction

The Government of the Republic of Mauritius is offering scholarships to deserving students who are resident citizens of member states of the African Union or of African Commonwealth countries for full-time, on-campus undergraduate (diploma/degree) and postgraduate (Masters/MPhil/PhD) programmes tenable in public Higher Education Institutions (HEIs) in Mauritius.

#### 1.0 Nomination Process

A Nominating Agency is typically part of the Ministry of Education in the country of the applicant. The Nominating Agency must ensure that the applicants meet ALL eligibility criteria and that ALL applications are complete prior to submission to the Mauritian Ministry of Education, Tertiary Education, Science and Technology.

## 1.1 Call for Applications

Nominating Agencies are kindly requested to disseminate the Call for the Mauritius-Africa Scholarship Scheme 2022 as extensively as possible and to receive and process applications from candidates.

All applications are to be made through the Nominating Agency, along with the necessary supporting documents.

## 1.2 Nomination Procedures

- 1.2.1 Nominating Agencies are required to nominate up to fifteen [15] applicants (five in each category of Undergraduate, Masters and MPhil/PhD).
- 1.2.2 Nominating Agencies should ensure that applicants satisfy all eligibility criteria and that the application paperwark is complete. Only applications endorsed by the Nominating Agency on the National Endorsement Earth will be considered by the selection committee in Mauritius. Only the best qualified candidates will be selected.
- 1.2.4 Originals of documents listed under Section 5 should be verified for an candidates selected by the Nominating Agencies.
- 1.2.5 Nominating Agencies should ensure that applicants submit the completed Mauritius Africa Scholarship Application Forms with all documents as listed in Section 6. The Nominating Agency is free to set an appropriate deadline to receive application and inform applicants of this deadline. Nominating Agencies are invited to allow for sufficient time for processing and forwarding the documents of nominated candidates to the Mauritian Ministry of Education, Tertiary Education, Science and Technology. - 1.3.3 The Ministry of Education, Tertiary Education, Science and Technology will NOT accept nominations that are received after set deadlines.

## 2.2 Application to the Higher Education Institutions (HEIs)

- 2.2.1 All applicants must have applied for at least one full-time on-campus programme at a public HEI of their choice (listed under *Section 7*). This application must be made as soon as the HEIs open their application windows on their respective websites.
- 2.2.2 An application may either be accompanied by:
  - (a) a conditional offer (letter of admission) from the applicant's chosen Mauritian public HEI;
  - (b) an acknowledgement notice from a Mauritian public HEI that the application for a seat has been made and the appropriate application fee has been paid.
- 2.2.3 Additionally, an application for postgraduate programme must be accompanied by a study/research plan and, for MPhil/PhD, the name of the proposed supervisor(s) in Mauritius.
- 2.2.4 ALL candidates must submit the fully completed **Application Form** and documents listed under **Section 6** as part of their application to their local Nominating Agency.

- 3.2.2 For Mastor's programmes, applicants should not have reached 35 years and for MPhII/PhD programmes, applicants should not have reached 40 years by 22 August 2022.

## 3.3 Required Qualifications

## 3.3.1 Qualification requirements to be eligible for Diploma Programme

(i). A information of five (3) credits at School Certificate of Secondary Education (IGCSE), inclusive of a credit in English Language or acceptable evidence of proficiency in English Language () as per noce (a) octow).

Or (ii). Five (5) 'O' Level passes awarded by any other approved examining body deemed to be equivalent to (1) above, inclusive of a pass in English Language or acceptable evidence of proficiency in English Language (as per note (d) below).

(iii) Qualification equivalent to (i)

#### Note:

- (a) A pass in English at A level will be acceptable in lieu of English Language at 'O' Level.
- (b) A pass at subsidiary level and/or 'A' Level or equivalent will be acceptable in lieu of a pass at 'O' Level as per (i) and (ii) above.
- (c) Some diploma programmes may have higher qualification requirements than (i) and (ii) and applications will be considered only for candidates meeting the minimum requirements of these programmes.
- (d) In case the language of instruction for the qualifying examination is not English, the candidate will have to provide a valid TOEFL test result with a minimum score of 550 (paper based) or 213 (computer based) or 79 (internet based) or IELTS with a minimum score of 5.5 or an acceptable proof of English Language proficiency.

## 3.3.2 Qualification requirements to be eligible for Undergraduate degree Programme

Candidates should have successfully completed end-of-secondary schooling and should satisfy the minimum grade requirements as indicated below:

- (i) at least 21 points at GCE A-Level which will be computed on the hasis of the following grades obtained in three Principal subjects: A+=10, A=9, B=8, C=7 & D=6; OR
- (ii) at least an overall average of 60% or an overall average of 12/20; OR
- (iii)qualification equivalent to (i) or (ii) above.

#### Note:

#### 1. Eligibility Criteria

#### 1.1 Nationality

Candidates must be resident citizens of member states of the African Union or of African Commonwealth countries. Mauritian nationals and foreign nationals residing in Mauritius are NOT eligible to apply under this Scheme.

#### 1.2 Age Limit

1.2.1 Applicants should be above 18 years of age and should not have reached their 26th birthday by 22 August 2022.

#### 1.3 Required Qualifications

## 1.3.1 Qualification requirements to be eligible for Diploma Programme

- 5.1.7 Awardees will have to make their own arrangements to pay for their one-way air tickets and then apply for refund upon arrival in Mauritius by providing the necessary original receipts and documentation. Those awardees travelling from countries that require a return ticket as a condition of their exit immigration at the point of departure will have to make arrangements for the same at their own cost.

The cost of the cancellation penalty fees of this return ticket will be refunded to the awardee by the authorities in mauritius.

## 1. Eligibility Criteria

#### 1.1 Nationality

Candidates must be resident citizens of member states of the African Union or of African Commonwealth countries. Mauritian nationals and foreign nationals residing in Mauritius are NOT eligible to apply under this Scheme.

## 1.2 Age Limit

Applicants should not have reached 35 years by 22 August 2022.

## 1.3 Qualification requirements to be eligible for Masters' programmes

Applicants should have successfully completed an undergraduate degree with:

- 4.1.2 Awardees will **NOT** be allowed to transfer to another HEI once they have been granted a Scholarship.
- 4.1.3 Awardees shall have to bear the cost of tuition fees and other studies-related costs exceeding the amounts mentioned above.

- 4.1.4 The awardee will have to bear all costs associated with any examination re-sit or repeat of any academic year.
- 4.1.5 The scholarship for MPhil/PhD studies will be for a maximum duration of four (4) years, plus a maximum period of 6 months for a transfer from MPhil to PhD.
- 4.1.6 The scholarship for PhD studies will be for a maximum duration of THREE (3) years
- 4.1.7 No request for an extension of scholarship will be entertained. The applicant will have to bear the cost of any expenses incurred beyond the time frames mentioned above.
- 4.1.8 No request for additional grants will be entertained.
- 4.1.9 Any costs related to fieldwork (either local or overseas) or the purchase of books will have to be borne by the student or the HEL.

## 4.2 Living allowance

- 4.2.1 Awardees are expected to come to Mauritius with sufficient funds to meet expenses during the initial phase of their stay, while they complete local formalities.
- 4.2.2 A monthly living allowance of MUR 12,500 will be paid to awardees to meet their living expenses in Mauritius. Students are expected to supplement this amount to cover the cost of living in Mauritius. This allowance will be credited to the awardee's bank account in Mauritius on a monthly basis, subject to the submission of evidence of enrolment and satisfactory attendance in the study programme by the HEL.
- 4.2.3 The payment of allowances during the final year of enrolment in the study programme will cover, on a pro-rate basis, a period of two (2) weeks following the final day of examinations.
- 4.2.4 An awardee should inform the Ministry of Education, Tertiary Education, Science and Technology in writing, at least **two (2) weeks in advance**, in case he/she has to leave Mauritius for any reason.

#### 4.3 Other conditions

The awardees should:

- (i) be vaccinated against the COVID 19 to have access to higher education institutions in Mauritius. For awardees who cannot for medical purposes be vaccinated, they will be required to produce duly certified medical certificates.
- (ii) abide to the protocol setup by Mauritian authorities for passengers travelling to Mauritius in the context of the Covid19 pandemic. The travel advice guide can be accessed by clicking on the link <a href="https://mauritiusnow.com/mauritius-travel-advice">https://mauritiusnow.com/mauritius-travel-advice</a>.
- (iii) be available to commence their academic studies in Mauritius by the start of the academic year of the respective institution in which they have been admitted;
- (iv) not be in receipt of a scholarship from any other public source in Mauritius;
- (v) undergo a medical check-up as per the Passport and Immigration Office requirements <a href="fhttp://passport.govmu.org">fhttp://passport.govmu.org</a>), in Mauritius and the tests results shall be submitted to the Passport and Immigration Office, with a copy to the Ministry, not later than one month after arrival in Mauritius.
- (vi) The Ministry reserves the right to request an applicant to undergo any such other medical tests as it deems fit.

#### 5. Travel to and from Mauritius

## 5.1 Student Visa and Travel Documents

- 5.1.1 Prior to an awardee's arrival in Mauritius, the HEI where the student has secured a seat will apply for a student visa with the Passport and Immigration Office (PIO) in Mauritius.
- 5.1.2 For visa application procedures, the awardee most liaise with the HEI where s/he has secured a place and ensure that s/he is holder of provisional entry permit issued by the PiO before arrival in Mauritius.
- 5.1.3 The PIO will process the student visa application and Issue a provisional entry permit valid for three (3) months to enable the student to travel to Mauritius.
- 5.1.4 Issuance of a provisional entry permit and student visa is subject to the immigration laws and policies prevailing in Mauritius.
- 5.1.5 Students must have a passport valid for the duration of the course enrolled.
- 5.1.6 The scholarship also covers a return airfare by the most economical route. This will be valid for travel from the country of origin at the beginning of the studies and back to the country of origin upon successful completion of studies.
- 5.1.7 Awardees will have to make their own arrangements to pay for their one-way air tickets and then apply for refund upon arrival in Mauritius by providing the necessary original receipts and documentation. Those awardees travelling from countries that require a return ticket as a condition of their exit immigration at the point of departure will have to make arrangements for the same at their own cost.

The cost of the cancellation penalty fees of this return ticket will be refunded to the awardee by the authorities in Mauritius.

## Note: Reimbursement of air ticket cost.

The authorities in Mauritius will refund airfare from awardee's country to Mauritius by the most economical route.

- 5.1.8 Students should inform in writing the HEI to which they have been admitted of their travel schedule well in advance.
- 5.1.9 Students who choose to have their family members or relatives or friends join them for visits in Mauritius will be fully responsible for their airfare, living expenses and any other expenses related to such visits.
- 5.1.10 If a HEI terminates the enrolment of a student or if a student decides to return to his/her country of citizenship before the completion of the course, he/she will NOT be entitled to a return ticket. This cost will have to be borne by the student himself/herself.
- 5.1.11 The student will not ne entitled to a refund of any expenses related to his/her travel during vacation time.
- 5.1.12 The awardce will sign an undertaking to leave Mauritius as soon as his/her programme of study comes to an end.

#### 5.2 Health and Travel Insurances

Beneficiaries are entitled to free basic health care in public hospitals in Mauritius. Awardees may wish to make their own arrangements for any health insurance and travel insurance.

#### 5.3 Accommodation

Awardees will have to make prior arrangements with the HEI in Mauritius concerning available accommodation facilities.

## 6. Other conditions of the Scholarship

#### 6.1 Submission of Progress Reports

The HEI will submit semester/annual academic progress reports and quarterly attendance reports for continuation of scholarship dishursements. These reports will be submitted to the Higher Education Commission and copied to the Ministry of Education, Tertiary Education, Science and Technology.

## 6.2 Renewal of Scholarship

- 6.2.1 Scholarships will be renewable yearly, subject to the successful completion of the nervious year of study and subsequent envoluent into the following year
- 6.2.2 The Government of Mauritius will discontinus scholarship disbut serients in case the student is not promoted to the next academic year Scholarship disbursement will only be resumed upon submission of documents certifying that the awardee has cleared any academic backlog and is enrolled in the following academic year or if progress of research work is behind schedule.

#### 6.3 Termination of scholarship

The scholarship may be terminated at any time for reasons of unsatisfactory conduct, progress or attendance, breach of the HEI Rules and Regulations or for any breach of the Mauritian laws.

- Certified copies of educational certificates
- Certified copies of transcripts
- Copy of letter of conditional offer by a public Higher Education Institution in Mauritius (if available at time of application) OR copy of acknowledgement notice from a Mauritian public HEI that the application for a seat has been made and the appropriate application fee has been paid;
- Medical certificate to be duly filled and signed by a registered Medical Practitioner in Section 6 of the Application Form. This should be appropriately stamped; and
- A detailed research plan
