- (2) Tuition Fees / Tuition Fees have been prepared in accordance with the "Decision Regarding the Determination of Tuition Fees and Contributions to be Taken as Student Contribution to Current Service Costs in Higher Education Institutions in the 2022-2023 Academic Year" published in the Official Gazette dated 27 July 2022 and numbered 31905.
- (3) CPI ) rates as the basis and complying with the frameworks determined by the Council of Ministers by the International Student Coordinator .
- (4) Students registered with the Foreign Student Quota are obliged to pay the first installment of the tuition fee during registration. In case of deregistration, the tuition fee is not refunded.

*Note: The program tuition fee is valid for the normal duration of that program, this period is 4 (four) semesters for master's programs with thesis, 2 (two) semesters for non-thesis master's programs, 8 (eight) semesters for doctoral programs accepted with a master's degree. and 10 (ten) semesters for doctoral programs accepted with a bachelor's degree. The student who cannot graduate at the end of the regular period is obliged to pay the additional fee to be determined by the University for each semester extended within the maximum period of the program.*

## ONLINE APPLICATION

### 1. What programs are available to apply?

Both Master's and Doctorate programs are available at the Graduate Education Institute.

### 2. What is the language of instruction in the department?

The language of instruction in all of our graduate programs is Turkish.

### 3. Application Principles

- a) Application dates, required documents and quotas are announced on the **web pages of the University, Institute and International Relations General Coordinatorship, taking into account the dates determined in the academic calendar** .
  - a. Candidates can apply to a maximum of 2 departments, but can only enroll in one of the departments announced by Adiyaman University Graduate Education Institute in the same period. Except for non-thesis master's programs, it is not possible to enroll in more than one graduate program at the same time.
- b) Graduates from undergraduate programs can apply to master's programs, and graduates from graduate programs (with thesis) can apply to doctoral programs.
- c) are made online to **Adiyaman University International Relations General Coordinatorship** between the dates specified in the announcement .
- d) Applications of candidates who do not meet the application requirements will not be evaluated.

### 4. What are the general requirements for applying?

In order to apply for a master's degree or a doctoral program with a bachelor's degree, on the condition of graduating from a bachelor's program of at least 4 years;

- a) Foreign nationals,
- b) Those who are Turkish citizens by birth but who have obtained permission to renounce Turkish citizenship from the Ministry of Interior and who certify that they have a Certificate on the Use of the Rights Granted by the Law No. 5203, obtained by their underage children, who are registered in the certificate of renunciation of Turkish citizenship,
- c) Dual nationals who are foreign nationals by birth and later become Turkish citizens can apply.
- d) The applicants must meet the conditions stated in the Higher Education Council's Principles Regarding the Acceptance of Students from Abroad.
- e) Diploma equivalency is sought according to the criteria determined by YÖK in programs affiliated to the Graduate Education Institute.
- f) The principles of “Regulations on Postgraduate Education Scholarships given by the Republic of Turkey” and the relevant decisions of the Higher Education Council are applied to international students with Turkish scholarship.

### 5. Who cannot apply?

Applications of the following candidates will not be accepted:

- a) Turkish nationals,



- b) Dual nationals who are Turkish citizens by birth and then acquire citizenship of another country,
- c) Those who have received disciplinary punishment from any Higher Education Institution in Turkey.

#### 6. Documents to be Uploaded in the Application;

- a) Translation of **undergraduate** or **graduate diploma** into Turkish or English approved by foreign representatives ,
- b) **Undergraduate** or Graduate **transcripts (transcripts)**. Certified translation from foreign representative offices into Turkish or English,
- c) **ALES, GRE or GMAT** exam result document (if any),
- d) **Diploma equivalency** certificate approved by YÖK for graduate education in related programs (must be submitted in the first month),
- e) **Turkish Proficiency Certificate** (if any), for applications to programs providing education in Turkish.
- f) **Foreign language exam result** document for applications to doctorate / Proficiency in Art programs and master's programs in a foreign language,
- g) **Copy of the passport,**
- h) **Copy of identity card,**

#### 7. Evaluation and Disclosure of Results

- a) In admission to graduate education with thesis; according to the undergraduate grade point average, students are accepted to master's programs with thesis within the quota.
- b) In admission to doctoral education; 70% of the master's grade point average with thesis and 30% of the foreign language score accepted as equivalent by YDS, YÖKDİL or YÖK is calculated and accepted to doctoral programs within the quota.
- c) **ALES result is not required from foreign students in postgraduate education applications**
- d) In admission to non-thesis master's education; according to the undergraduate grade point average, students are accepted to non-thesis master's programs within the quota.

#### **Important note: Candidates applying to health programs affiliated to the Graduate Education Institute ;**

- ❖ School Recognition Letter (Recognition) from YÖK for health fields that do not require clinical practice;
- ❖ Diploma Equivalency Certificate obtained from the Council of Higher Education (YÖK) is obligatory for health fields with clinical application.
- ❖ ALES result is not required from international students in postgraduate education applications.
- ❖ at least **55 points from the foreign language score type determined by the Department of Science/ Main Art** , from YDS/YÖKDİL or one of the exams, the equivalence of which is determined by the ÖSYM Foreign Language Examinations Equivalency Determination Directive . Foreign language proficiency certificate is not required from applicants from countries whose official language is English, German, Arabic or French, or from schools whose language of instruction is 100% English, German, Arabic or French.
- ❖ Foreign language requirement is not required for applications to Master's Programs whose medium of instruction is Turkish. For applications to Master's Programs where the medium



of instruction is English, the Foreign Language requirement is sought and the desired language level is specified in the advertisements.

- ❖ Candidates applying to a doctoral program with a bachelor's degree must have a minimum grade point average of 3.00 or equivalent for the 4-point system. Candidates applying to graduate programs should have a grade point average of **2.50/4.00 for master's programs, 2.75/4.00** for doctoral programs, or the equivalent of their grades in the 4th System of the Council of Higher Education.
- ❖ In the evaluation of candidates who apply to distance education master's programs without thesis, a ranking is made according to the candidates' undergraduate graduation grade point averages. However, in mandatory cases, interviews can also be conducted using the distance education system infrastructure of our university, if the relevant department deems it appropriate.

## 8. Turkish Language Proficiency

- a) International students must know and document Turkish at least at B2 level in order to enroll in courses.
- b) In order for international students to graduate, they have to obtain a C1 level Turkish language certificate until the end of their maximum period. Otherwise, they will not be able to graduate and receive a diploma and their registration will be deleted at the end of their maximum term.
- c) Students who have the right to final registration and who certify that they know Turkish at the B2 level are assigned an advisor after the final registration is made. The student, who is appointed as an advisor, starts his/her academic education by registering with his/her advisor.
- d) At the beginning of each academic year, on the dates announced on the related institute website, Adiyaman University TÖMER conducts the Turkish Language Level Examination for graduate students. Those who receive a B2 Level Turkish Language Certificate in this exam conducted by TÖMER can start their academic education.





- e) Students who do not have a B2 or higher level certificate must **only attend the Turkish preparatory education given by Adıyaman University TÖMER**. Turkish preparatory education lasts for two semesters at most. This period can be extended for a maximum of one semester with the proposal of the Institute Department / Department / Program and the decision of the Institute Administrative Board. At the end of these periods, those who cannot obtain a certificate at least at B2 level from the TÖMER exam or other exams accepted by the Institute Administrative Board are dismissed from the Institute.
- f) Students who are accepted to the Institute with the condition of Turkish preparatory education **have to get their Turkish education only from Adıyaman University TÖMER**. Otherwise, the student is dismissed from the Institute.
- g) A student who is registered to the relevant Institute and continues his education at TÖMER in order to obtain a Turkish language certificate can start his academic education only at the beginning of the academic semester (within the first two weeks according to the academic calendar), even if he receives a B2 language certificate in a mid-term exam of TÖMER. .

**Turkish Language Proficiency Levels According to ADYU TÖMER**

## 9. Registration Process

- a) Application documents specified in the announcement are submitted to the institute between the relevant dates and as specified (in person or by proxy). Applications made outside the conditions and procedures specified in the announcement and



applications of those who cannot deliver their documents to the institutes on time are not accepted. Applications of candidates who present incomplete, fake, illegible or incorrect documents in the application process will not be considered valid.

- b) In order for the registration process to be carried out, the originals of the necessary documents must be submitted at the time of registration. Among the candidates who have earned the right to register, those who do not register within the announced period are deemed to have lost their right to register.
- c) For graduation certificates received from abroad, information about "School Recognition" will be requested from the Higher Education Council after registration.
- d) Students who complete their registration to the program must choose the courses to be taken between **06-12 February 2023 and have it approved by the registration advisor**. Otherwise, it will be considered as not registered due to incomplete transactions.

## 9. What are the Documents Required for Final Registration?

The following documents are requested from the candidates for application:

- a) Application form,
- b) Letter of acceptance,
- c) Certified copy of undergraduate or graduate diploma translated into Turkish or English approved by foreign representatives,
- d) Undergraduate and graduate transcripts and a certified copy translated into Turkish or English,
- e) ALES, GRE or GMAT exam result document (if any),
- f) Diploma equivalency certificate approved by YÖK for graduate education in related programs,
- g) Foreign language certificate (One of the foreign language exams accepted by the Institute)
- h) Turkish proficiency certificate (if any),
- i) Copy of identity card,
- j) Photocopy of the passport,
- k) One (1) photograph,
- l) Application fee receipt,

\*Applicants with missing application documents will not be evaluated.

## 10. Obligations of International Students;

### Foreign Students;

- a) Obtaining a residence permit (within 1 month from the date of entry with a student visa),
- b) Notifying the Provincial Directorate of Migration Management of changes in educational status (faculty, department changes, etc. ) in due time,
- c) Notifying the Graduate School of changes in personal, marital and educational status





- within 10 days at the latest,
- d) If they want to extend their stay during their education, by obtaining a new one from the local Provincial Directorate of Migration Management, 60 days before the expiration of the period written in their residence permit or within 10 days after the expiry of the period, provided that they document that they continue their education,
  - e) In case of losing their residence permit or passport, applying to the relevant authorities immediately and getting a new one within 10 days,
  - f) Foreign students enrolled in the university can become universal health insurance holders by paying a general health insurance premium, if they make a request within three months from the first registration date.
